1. For all polluted areas complete monitoring (as per Annexure A) for all designated parameters shall be performed.
2. It shall be at sole discretion of the competent authority (BSDS) to award the work.
3. The tentative list of parameters for ambient Air Quality, Potable/Waste Water Quality and others is given in Annexure A.
4. The rates for sampling and analysis (including transportation, sampling and other miscellaneous charges) should be included for charges per sample per location.
5. Tax shall be paid as per applicable norms and TDS shall be deducted as per applicable.
6. The executing agency shall carry out sampling, and analysis as per the procedure and norms stipulated in "Standard Methods" of MPPCB /CPCB.
7. The executing agency shall submit the complete sampling and analysis reports including summary of the parameters exceeding the prescribed standard /norms.
8. The executing agency shall co-ordinate with the MPPCB officials for efficient monitoring and sampling work.
9. All the information and data generated or collected during the execution of work shall be treated as confidential and sole property of BSDS.
10. It shall be at sole discretion of competent authority BSDS, to differ the entire work or part of the work or reject any proposal without assigning reason thereof.
11. Proposal being submit must be signed by an authorized person representing the company/firm & same to be submitted online too.
12. The work order shall be valid for 01 year from the date of issue of work order & Shall be extendable further for a maximum period of 01 year as per requirement of BSDS and agency shall undertake monitoring /work at the approved rates.
13. **Payments:-**The payment shall be made on Monthly/ Quarterly basis after submission of various test reports (as per annexure A) along with invoices. The payment for ESR (Yearly) will be done after submission of ESR along with invoices.

**Force Majure :-**

If, at any time during the continuance of this Contract the performance in whole or in part by either party of any obligations under this Contract shall be prevented or delayed by reason of any War, Hostile acts of the public enemy Civil Commotion, Pendemics (Covid-19) Epidemics, or Acts of God (Floods, Storm/Cyclone, Hurricane, Earthquake etc. ) then provided notice of happening of any such event is given by either party to other within 7 days from the date of occurrence there for neither party shall by reason of such event be entitled to terminate this Contract nor shall either party have any claim for damages against the other in respect of such non-performance and delay in performance under the contract shall be resumed as soon as practicable after such event has come to an end or ceased to exist. If the performance in whole or part of any obligation under this Contract is prevented or delayed by reason of any such event, claims for extension of time shall be granted for periods considered reasonable by the Manager /Stores/Valves subject to prompt notification by the contractor.

**LIQUIDATED DAMAGES (LD)/PENALTY:**

If the contractor fails to complete the service/work or part of service /work as per terms & conditions of the MPPCB Rules.

- a) LD shall be levied @ 0.5 % of the order value per week of delay or part thereof subject to a Maximum of 10% of the full order value.
- b) In case of any change to the order value, the LD shall be @ 0.5 % of the revised order value per week of delay or part thereof subject to a maximum of 10% of the revised order value.

**EMD (Earnest Money Deposit) & Tender Fee:**

- 1. EMD of Rs. 5000/- to be paid online while filling the e-tender.
- 2. Tenders submitted without EMD payment shall be rejected.
