- 1.1 The tenders should clearly state their offers and the address for communication together with their E-mail address, telephone and Fax No. Any change in the address should immediately be notified to the General Manager, Cattle Feed Factory, Pachama so that the correspondence thereafter may be made at their changed address.
- 1.2 The CEO will have full right to accept bid in full, partial or split orders for supply of POLYSTER BAG WITH D SYSTEM FOR AREA SPECIFIC MINERAL MIXTURE.
- 2.0 **EARNEST MONEY DEPOSIT**
- 2.1 The tenderers shall have to pay Earnest money of Rs. 25,000/- (Rupees Twenty Five Thousand only) Online Only. MSME of the state are exempted from EMD
- 2.2 No interest will be paid on the earnest money for the period during which it lies in deposit with the Cattle Feed Factory.
- 3.0 **BID OFFER :-**
- 3.1 The prices quoted will be treated as F.O.R. destination, inclusive of packing forwarding, GST, insurance & transportation charges etc.
- 4.0 **MODE OF DESPATCH :**
- 4.1 On receiving orders from Cattle Feed Factory, Pachama the supply of material at Cattle Feed Plant, shall be the responsibility of the supplier, Quality inspection and rejection if any, shall be made at the Cattle Feed Plant Sites. The rejected quantity, if any, shall be lifted by the supplier at his cost  
The rejected material shall have to be lifted by the supplier within a week from the date of intimation from Cattle Feed Plant. The Cattle Feed Plant shall not be responsible for any deterioration due to delayed lifting of the rejected material by the supplier.
- 5.0 **INSURANCE:**
- 5.1 Insurance shall be arranged by the Supplier at his cost.
- 6.0 **PAYMENT:**
- 6.1 Our normal terms of payment is 80% payment on acceptance of material after inspection within a period of seven days after receipt. The payment shall be made Through RTGS only. The remaining 20% Payment will be released after quality check within thirty days of the receipt .
- 6.2 New/existing supplier will have to make the cylinder at his own cost. No extra payment shall be made by Cattle Feed Factory, Pachama. During period of contract the design of material can be changed as on when required extra charges will be borne by supplier.

7.0 **STATUS OF TENDER:**

7.1 The acceptance of the tender, and award of the purchase order will be the sole right of the CEO BSDS who does not bind himself to accept a tender in whole or in a part. CEO BSDS reserves the right to reject the tenders or their part without assigning any reasons thereof.

7.2 The duration of the tender will be 1 year only which can be extended further up to 6 month, on mutual agreement.

8.0 **LIQUIDATED DAMAGES & PENALTIES:**

8.1 The supplies should be made as per given schedule. In case they are not followed. The incharge of the CFF reserves the right to make alternative purchases from open market and the difference of cost if any, shall be recoverable from the defaulting supplier. In case the supplies are not made as per schedules the liquidated damages may be charged on the goods not so delivered as under:-

**Duration of delay****Penalty**

a) 15 Days

1% of the value of goods.

b) 16 to 30 Days

2% of the value of goods.

c) After 30 Days

5% of the value of goods and/or the purchase order shall be treated as cancelled and the EMD shall be forfeited.

9.0 **INSPECTION:**

9.1 All the stores are subject to inspection before acceptance. If goods are rejected due to defective or wrong supply, the report of our inspector in this respect shall be final and no correspondence on the subject would be entertained. The rejected goods should be lifted from the CFF within seven days after receipt of our inspection report as stipulated in clause (4.1) failing which the same shall be returned to the supplier at his risk and expenses.

10.0 **SAMPLES:**

10.1 If required the Quality Control Deptt. of Cattle Feed Factory may draw sample equivalent to 10 Bags and shall forward the samples for checking the specification, composition and the standard parameter as laid down in tender specifications by the independent agency as under:

Following Tests shall be carried out by these agencies :-  
Measurement Test.
  2. Tensile Strength/ Elongation Test.
  3. Bursting Strength Test.
  4. Ink Quality Test.

- 10.2 The POLYSTER BAG WITH D SYSTEM FOR AREA SPECIFIC MINERAL MIXTURE shall be rejected in case of following:  
A. In case length/width of the bag is not uniform./ or not as per the norms.  
B. Poor Printing quality.
- 11.0 **WHARFAGE/DEMURRAGE:**  
11.1 Wharf age/Demurrage etc. on account of incorrect or delayed dispatch of material or documents shall be the responsibility of supplier and shall be recovered from his bill.
- 12.0 **TERMINATION OF CONTRACT:-**  
Any breach of the terms and conditions of tender shall render the contract liable to termination / blacklisting of the firm, in addition to the recovery towards etc.
- 13.0 **DRAWING & SPECIFICATIONS :-**  
Rate should be quoted as per the specifications given in the Schedule - III CFF Pachama is not bound to consider the cases in which there are deviations from the prescribed specifications. Only those units shall be eligible to participate in the tender who are equipped with the facilities of manufacturing POLYSTER BAG WITH D SYSTEM FOR AREA SPECIFIC MINERAL MIXTURE
- 14.0 **FINAL AUTHORITY:-**  
14.1 It should be clearly understood that in the event of tenderer failing to accept and execute the supply order, decision of the CEO for imposing penalty etc. shall be final and binding on the tenderer.  
14.2 At the time of submitting the tender, the tenderer shall supply detailed information about their activities in the enclosed format annexed to Schedule – III.  
14.3 In matters of interpretation of the above clauses, the decision of the CEO shall be final and binding on all concerned.  
14.4 For all disputes the jurisdiction shall be Bhopal No court outside Bhopal will have any jurisdiction.
- 15.0 **ARBITRATION:**  
15.1 It should be clearly understood that in the event of a successful tenderer failing to accept and execute the supply order, then decision of the Chief Executive Officer, Bhopal Sahkari Dugdha Sangh Maryadit in this respect will be final and binding on the successful tenderer.  
15.2 In any case of dispute between material /services supplier and Bhopal Sahakari Dugdha Sangh matter will be presented to MD, MPCDF for resolution.  
15.3 All disputes between tenderers and BSDS matter will be put to MD, MPCDF for resolution. In case no resolution action will be taken as per Arbitration ACT.1996.  
15.4 For all disputes, the venue for legal course shall be at Bhopal.  
15.5 If the tender opening date become any govt, holiday then the next day may be considered for tender opening.

16.0 **AGREEMENT:**

16.1 Approved tenderer shall have to execute an agreement on a non-judicial stamp Paper of Rs. 1000/- as per terms and conditions of this Tender with the Cattle Feed Plant which shall be valid for 1 year from the date of execution of Purchase Agreement.

The Present agreement will be effective for a period of 1 Year from the date of agreement. The contract period can be increased further up to 6 month on the ground of satisfactory supply and quality of material.
