General Terms and Conditions for Supply of spare parts for Super Senior extra wide (Jumbo) Pellet Machine and other Plant Machinery.

1. B.S.D.S. reserves the right to accept or reject the tender wholly or part thereof without assigning any reason.
2. Rates Quoted should be FOR Sehore for Pachama Plant P&F, Taxes, Duties etc should be included in quoted rules. Any rise in duties/ taxes/levies from Govt. authorities will be considered in further accordingly.
3. Price Bid to be submitted online only at MP State E-Tender Portal www.mptenders.gov.in . Scanned copy of EMD to be uploaded online.
4. The tenderers are directed to inform Cattle Feed Factory, Pachama Sehore immediately if there is any change in their address, phone numbers or any other contact details.
5. The earnest money will be Rs. 1,00,000/- (Rs. One Lakh only). All tenderers are directed to submit earnest money Online Only.
6. No interest shall be paid on the Earnest money.
7. In case of non supply / short supply CFF Pachama unit reserves the right to purchase material from other suppliers and difference in cost will be adjusted from supplier's pending bills / Earnest money Deposit.
8. For wrong address and other related information, tenderer shall be responsible.
9. Conditional tenders shall be rejected outrightly.
10. Tenderers can visit Cattle Feed Factory Pachama for any technical query to avoid any confusion regarding specifications of the spare parts.

Delivery Terms :-

1. Entire Quantity of all material to be supplied to plants as per their requirement and as per schedule given.
2. All the material rates quoted be FOR Sehore for our Pachama Plant, (MP)
3. All material are required to be supplied in proper packing along with greasing on dies and roller shells. Material may be supplied in plastic or in Wooden packing to enable us to use it over a long period.
4. Wherever needed proper anti- corrosion solution will be applied.
5. Rate approval shall be extended for next one year subject to satisfactory quality of spares supplied.

Quality Guarantee and related terms:-

1. All the Supplied material should be guaranteed against all manufacturing and performance related defects for a period of one year from the date of supply.
2. Supplier should take special care for finished sizes on all components to ensure proper fitting and interchangeability of all parts.
All fitting related problems shall cause an outright rejection of components.
3. All rejections will be returned and replaced totally on suppliers cost and liability.

Payment Terms :-

- 1 Payment will be made for their respective supplies within 35 days of receipt of material and quality inspection at site.

Delay Penalty Clause :-

Disputes and Redressals :-

1. Decision on any dispute arising out of this tender and routine supply will be redressed by C.E.O of BSDS BHOPAL.
2. In case of any litigation, place of jurisdiction will always be Bhopal for Pachama.
3. All quality related problems will be redressed by the General Manager of plant.
4. Each supplier will have to supply Test/ Quality / Guarantee Certificate on company's letterhead for each of their supplies. These certificates should cover all defects against workmanship / manufacturing / performance standards / fittings.

ARBITRATION :-

1. It should be clearly understood that in the event of a successful tenderer failing to accept and execute the supply order, then decision of the Chief Executive Officer, Bhopal Sahkari Dugdha Sangh Maryadit in this respect will be final and binding on the successful tenderer.
2. In case of dispute between supplier and Bhopal Sahakari Dugdha Sangh related to any matter the case will be presented to MD, MPCDF for resolution.
3. All disputes between tenderers and BSDS matter will be put to MD, MPCDF for resolution. In case no resolution action will be taken as per Arbitration ACT.1996.
4. For all disputes, the venue for legal course shall be at Bhopal.
5. If the tender opening date become any govt, holiday then the next day may considered for tender opening.

WHERE AS the contractor / supplier has offered Spares Parts confirming to as per tender No ----- Dated -----to the nominated consignee as specified in the tender document is Rs. ----- FOR Pachama as per terms and conditions of this Tender with the Cattle Feed Factory Pachama. Agreement will be effective for a period of One Year from the date of awarding contract. The contract period can be increased for one Year mutually. Where as once firm delivery dates are communicated by Cattle Feed Factory, Pachama the same be strictly adhered to and essence of the contract. the supplies should be made as given schedule, In case they are not followed Chief Executive Officer, Bhopal Sahakari Dugdh Sangh Maryadit Bhopal reserves the right to make alternative purchases from open market and the difference of cost, if any shall be recoverable from the defaulting supplier. In case the supplies are not affected as per schedules the liquidated damages may be charges on the goods not so delivered as under :-

Duration of delay

- a) 15 Days
- b) 16 to 30 Days
- c) After 30 Days

Penalty

- 1% of the value of goods.
- 2% of the value of goods.
- 5% of the value of goods and/or the purchase order shall be treated as cancelled and the EMD may be forfeited.

Where as our normal terms of payment are 80% payment on acceptance of material and 20% after inspection. The payment shall be made by RTGS only. Where as No price escalation shall be give in contract period. Where as material do not confirm the above standard. The same shall be liable for rejection / rebate and first party has to lift the material at his own cost with in 7 days. Delay in lifting shall attract storage charges as per the rule of CFF, Pachama. Now therefore the agreement witnesses and it is hereby agreed in accordance with terms and conditions of tender Document.
