#### General Terms & Conditions for tender submission & supply

Bhopal SahakariDugdhaSanghMaryadit, Bhopal (BSDSM), an ISO certified cooperative organization, invites online e tender from bonafide manufacturers and/ or their authorized dealers or other suppliers for supply of PACKING MATERIALS strictly in adherence to the detailed specifications given in the schedule II of the tender documents.

Bhopal SahakariDugdhaSanghMydt., Bhopal reserves the right to accept or reject any or all tenders, which in their opinion justify such actions, without further explanation to the tenderers.

#### 1.0 <u>DECLARATION</u>:

The submission of a tender by a tenderer implies that he/she has read the notice and conditions of the tender and the terms and conditions of contract and has made himself/herself aware of scope and specifications of the supplies to be made and the destination where the supplies have to be made and satisfied himself/herself regarding the quality and specifications of the articles.

#### 2.0 TENDER SUBMISSION:

- 2.1 Tenders received by e-mail will not be considered. However, amendments by e-mail to a tender sent will be considered, provided the same are received before the opening of the tender
- 2.2 The tenderer(s) should clearly state in their offer the address, telephone, e-mail, PAN and GST Numbers. Any change in the address should immediately be communicated to the Chief Executive Officer, Bhopal Sahakari Dugdh Sangh Mydt, Bhopal and correspondence thereafter will be made at the changed address.
- 2.3 Negligence on the part of tenderer in filling the tender form offers him/her no right to withdraw the tender after it has been opened.
- 2.4 The acceptance of the tender and award of the purchase order will be the sole right of the Chief Executive Officer, Bhopal Sah. Dugdha Sangh Mydt. who does not bind himself to accept a tender in whole or in part or reject any or all the tenders received without assigning any reasons and no explanation can be demanded of the cause of rejection of the tender by any tenderer.
- 2.5 The Chief Executive Officer, BSDSM reserves the right to place order for whole requirement with any tenderer or split the orders among one or more tenderers or not to purchase at all any item even after rate approval.
- 2.6 Each tender should be accompanied with copy of PAN, GST, Firm Registration, ITR of any one Assessment Year.
- 2.7 The tenderers should submit the rates online only. The conditional tenders are liable to be rejected.
- 2.8 No person or firm is permitted to submit more than one tender under different names.
- 2.9 The tenderer shall not sublet the contract or assign to any other party or parties, the whole or any portion of the contract without prior written permission of Chief Executive Officer, BSDSM.

- 2.10 Manufacturers will be given preference. Copy of license is to be attached with tender for each item filled in, wholesalers dealing with the item will have to attach copy of authorization certificate of the manufacturer.
- 2.11 Tenderer shall fill all the details of the unit in Form- A in schedule-III. (To be uploaded mandatory.)
- 2.12 Tenderer offering rates for packing materials shall submit Food Grade Certificate and COA, NABL Lab analysis report at the time of supply. (if needed).

#### **Bid Validity**

Bid shall be valid for a period of 90 days from the date of opening.

#### Bid price

Price indicated on the price schedule shall be inclusive of pkg/frdg, freight and Cylinder/dye making charge, if any. GST (to be shown extra)

Note:-When submitting EMD online please note that you pay only the EMD of particular item you would like to offer the rate. By choosing "Yes" option (in mptenders.gov.in portal) so as to enable you for EMD exemption.

#### 3.0 Earnest Money Deposit (As per Schedule-II)

- 3.1 EMD should be submitted online only and attach copy of proof for payment of EMD in technical bid.
- 3.2 **MSME industries** of **TheMadhya Pradesh State** will be exempted from payment of the EMD and tender fee of the tender. MSME certificate should be of relevant category of supplies/materials/works.(MSME Certificate to be uploaded online mandatory)
- 3.3 Any tender which is not accompanied by Earnest Money deposit are liable to be rejected. Earnest money deposit of unsuccessful tenderers will be returned within 90 days from the date of opening of the tender. The earnest money deposit of the successful tenderers will be released on completion of supply/work as the case may be within the stipulated period.
- 3.4 No interest will be paid on the earnest money for the period during which (the EMD) lies in deposit with Bhopal SahakariDugdhaSangh.Maryadit.
  - EMD may be forfeited:
    - If successful Bidder/supplier fails/denies to perform work
    - If any bidder/supplier withdraw its bid during the bid validity period

#### 4.0 PRICES:

- 4.1 Prices offered by the tenderers should be valid at least for a period of 12 months from the date of approval of rates. BSDS will have the right to extend the validity of the tender approval by 6 months. We would communicate our rate approval within 60 days of opening of tender. The tenderer should quote rate on FOR dairy plant, Bhopal basis, GST extra.
- 4.2 If need be, negotiations will be done for prices and as well as terms & conditions of material supply only with the party which offers the lowest rate.
- 4.3 The prices charged for the material supplied under the contract by the supplier firm in no event shall exceed the lowest price at which the supplier firm sells the material of identical tender description to any other persons/firms during the period and until the execution of all supply orders placed during contract period.
- 4.4 The lowest rate shall not be the only criteria for approving the tender.
- 4.5 BSDS Bhopal will have right to purchase materials from the other bidders whom participated in the same tender and willing to supply the material on L-1 approved rates for which BSDS will take the consent of other bidders too. For the issue of purchase order the proportionate ratio will be 60:40. (60% Order for L1 Bidders and 40% Order for other Bidders)

#### 5.0 MODE OF DESPATCH

- 5.1 The material to be supplied by successful firm shall be dispatched to the dairy under prior intimation. Depending upon the type of material, the supplier shall have to carry out proper packing/crating to avoid damage during transit.
- 5.2 Wharfage /Demurrage etc. on account of incorrect or delayed dispatch of material/documents shall be the responsibility of supplier and shall be recovered from the bills.
- **FOOD GRADE CERTIFICATE** from NABL lab for the material coming in direct contact of food is to be provided with every supply as per FSSAI packaging regulation 2018 clause 3.2 & 3.14.
- **PRINTING:** Printing work on each & every items should be printed as per BSDS approved artwork.
  - a) If printing found faded/blurred then a penalty of 5% cost will be imposed.
  - b) If items Specifications found lesser than as specified in tender specification then a pro-rata deduction will be made.
  - c) The barcode printing found unreadable then entire supply will be rejected.

#### 8.0 LIQUIDATED DAMAGES;

8.1 The time period and the date of delivery of the material stipulated in the purchase order shall be deemed to be the essence of the contract. Once firm delivery dates are fixed for supply of material they shall be strictly adhered too. In case they are not followed, or in case of delay in execution or non-execution of the order, the Dugdha Sangh reserves the right either to cancel the order and make alternative purchases from other sources, at the risk and cost & expenses

of the defaulting supplier. In case the supplies are not affected as per the schedules, the liquidated damages may be charged on the goods not so delivered as under:-

Sl.No.	Duration of delay	Liquidated Damages
1.	Upto 15 days	1% cost of the unit.
2.	Between 16 to 30 days	2% cost of the unit
3.	Beyond 30 days	Upto 5% cost of the unit.

- 8.2 If the tenderer fails to make supply as per purchase order without any valid reason, the order would be treated as cancelled and the firm may be blacklisted for future dealings and EMD also would be forfeited by the management.
- 8.3 If the qualified tenderer fails to make supply the materials as per specification/material quality/printing as per BSDS's approved artwork/specification, then the entire requirement shall be fulfilled through the other bidders and if the other bidders didn't agree to supply the material on L-1 approved rates the difference amount would be charged from deposited EMD or their pending bills of L-1 bidders.

#### 9.0 **INSURANCE**:

Insurance is to be arranged by the tenderer.

#### 10.0 INSPECTION:

- 10.1 All the supplies are subject to inspection at our plant before acceptance. If goods are rejected due to defective or wrong supply, the report of our authorized official in this respect shall be FINAL and no correspondence on the subject would be entertained. The rejected goods should be removed from our premises by the tenderer within 15 days after receipt of our inspection report failing which the same shall be returned to the supplier at his risk and expenses or disposed off in Auction and the proceeds, if any, less expenses would be credited to tenderer's account.
- Sample of the articles should be sent/produced before the competent authority if asked for within 7 days or as mutually agreed.

#### 11.0 ACCEPTANCE / PENALTY:

- 11.1 Material must be supplied as per specification of BSDSM Bhopal.
- 11.2 If printing found faded/Blurred then a penalty of 5% cost will be imposed in an emergency requirement otherwise the full consignment shall be rejected.
- 11.3 If item's GSM found lesser than as specified in tender specification then a pro-rata deduction will be made in an emergency used otherwise the whole consignment shall be rejected.
- In such condition when deficiencies are found more than one than the decision of CEO on recommendation of purchase committee shall be final.
- In condition, if any consignment happens to declared as rejected, the supplier should have to visit BSDSM to know the causes for his own satisfaction.
- 11.6 The rejected material shall not be return to the supplier. To avoid any misuse of rejected material it shall be destroyed within a stipulated time of not more than 1 month, in presence of supplier at supplier cost and no payment shall be made for the rejected material.

#### **12.0 PAYMENT:**

Our normal terms of payment are full payment after receipt, inspection and acceptance of materials in our stores within a period of about 30 days after receipt. Such payments shall be made through RTGS.

#### 13.0 TERMINATION OF CONTRACT:

If any act of commission or omission of a unit under contract brings Bhopal Sah. Dugdha Sangh Mydt. to dispute, then Bhopal Sahakari Dugdha Sangh Mydt. shall be competent to debar/blacklist the unit from further business.

#### 14.0 CONSEQUENCES OF BREACH OF AGREEMENT:

If any firm under the contract commits breach of any of the conditions, it shall be lawful for the Chief Executive Officer, Bhopal SahakariDugdhaSanghMydt. to cancel the contract and to purchase material from any other alternate sources on the risk and cost of the defaulting unit.

#### 15.0 DISPUTE ARBITRATION & FINAL AUTHORITY:

- 15.1 It should be clearly understood that in the event of a successful tenderer failing to accept and execute the supply order, then decision of the Chief Executive Officer, Bhopal SahkariDugdhaSanghMydt., in this respect willbefinalandbindingonthesuccessfultenderer.
- 15.2 In any case of dispute between material / services supplier and Bhopal SahakariDugdhaSangh matter will be presented to MD, MPCDF for resolution.
- 15.3 All disputes between renderers and BSDS matter will be put to MD, MPCDF for resolution. In case no resolution action will be taken as per Arbitration Act. 1996.
- 15.4 Foralldisputes, the venue for legal courses hall be at Bhopal.
- 15.5 If the tender opening date become any govt. holiday then the next day may considered for tender opening.

#### **Basic requirements for corrugated boxes**

- 1) Cardboard Box colour outer paper should be in white paper duplex.
- 2) Construction— All universal type boxes shall be constructed from single piece double walled 5 ply or 3 ply heavy duty fibre board as per requirements, conforming to ISI 2771 Part 1 `1977 and subsequent revisions (1990). The fibre board must be derived from virgin kraft paper conforming to ISI-1397-1976 grade II. Only variation of ± 1% from the specified grammage for all plies for all types of boxes is permissible.

All five or three plies shall be unbituminized and each ply shall be of gsm as stated above. The second and fourth ply shall be corrugated and embodied into the outer ply in a manner such that they cannot be separated by pulling apart without damaging the paper and tearing it. All plies should be constructed from requiredgsm virgin kraft only.

- 3) <u>Corrugation</u> -The height of corrugation should be between 2.1 and 2.9 mm and there should be 150 to 155 corrugations per running metre length or better.
- 4) <u>Gum/ Adhesive</u>— Any suitable adhesive capable of firmly adhering the various piles together may be used. Sodiun silicate or any other highly alkaline adhesive shall not be used. The adhesive shall be applied not nearer to a cut edge than 3mm, and not nearer to a cease at the end of the lap than 12mm, gums/glues permissible under law for sticking as per FSSAI/legal standard to be used for packing. The adhesive used for the joint shall be water resistant type.
- 5) <u>Creasing, Scoring, Folding</u> The boxes should be creased and scored such that folding is appropriate and symmetrical.
- Printing- Printing on outer surface, printing shall be neat and clean without any defects. Proper quality ink shall be selected. Also, it shall not show any significant removal of the printed ink. Printing will be as per approved artwork. All boxes to be printed as per prescribed design and multi colour as per MPCDF/Union art & design. Permissible ink to be used as per law. Each box shall be legibly and indelibly marked.
- 7) <u>Joints</u> All boxes should have lap type of joints with minimum width of 30 mm. All stitches should be on the central axis of the lap at an angle of 45 degrees and total eight staplesnon rusting in 100g x 20 cups, white butter total 12 staples non rusting. Ghee 01ltr. & 500ml. should10 staples non rusting should be used including double staples on upper and lower ends of the joints of boxes. Only GI wire of 12 to 25 SWG should be used for stitching.
- 8) Packing Boxes should be packed in bundles containing 20 units of each type of box and should be marked with supplier's name and/or initials/trade mark, batch No., lot No. and dimensions. Material to be suitably packed to prevent damages during transit. Bundles of 20 Nos packed properly with an outer cover to avoid dust.
- 9) <u>Hygiene</u> All boxes shall be clean, dry and free from fungus, insect infestation, dust any type of deformities etc. As the boxes will be used to pack food products, extra care should be taken for maintenance of cleanliness and delivery of the boxes in the dairy in most hygienic condition.
- 10) <u>Cardboard separator</u> Separator One/Two to maintain proper stacking of Cup/Glass for strengthing purpose. Ply-03, GSM-125±1% ,B.S-7±1 kg/cm<sup>2</sup>
- 11) <u>Specific requirements</u>- The material, used for the packaging of food materials, shall be manufactured from virgin pulp and shall be free from dioxins. Printed surface of the paper

shall not come into contact with the food and the maximum amount of contaminants in paper intended to come into contact with food shall not exceed the limits prescribed in IS 2771. Testing-The type of test to be performed as per laid down tender conditions and above 12) parameters. \*\*\*\*\*
