2. Supply of packaged MAIZE SILAGE to Bhopal Sahakari Dugdha Sangh Bhopal or any agency appointed by It on its behalf on an exclusive basis.

3. Contract Period-

The tenderer's contract period will remain effective for Three years on completion of the said period, if the performance of the tenderer is satisfactory, the right to extend the contract period of Two Years (1+1) on the same terms and conditions will be the right of the chief executive officer.

4. Security Deposit –

Raw Material:-

- High-quality maize harvested at the optimum maturity stage.
- The maize should have a moisture content of 65-70 % for effective ensiling.

Chopping Specifications:-

- The maize must be finely chopped to ensure proper compaction and fermentation.

Compaction and Ensiling:-

- Silage must be compacted in air tight storage to eliminate oxygen and initiate anaerobic fermentation.

Fermentation:-

- The ensiled material must be sealed and left to ferment for a minimum of 21-30 days.
- Fermentation should achieve a pH of 3.8–4. 2 for optimal preservation and nutritional value.

Nutritional Content:-

- Crude Protein (CP): Minimum 7-9 %.
- Dry Matter (DM) :25-35 %.

Packaging and Storage:-

- Pack silage in air tight, UV-resistant plastic bags / bales of 50-100 kg.
