SCHEDULE-I

GENERAL TERMS AND CONDITIONS

The Bhopal Sahakari Dugdh Sangh Mydt., Bhopal invites sealed tenders on behalf of Cattle Feed Factory, Pachama from manufacturers/associations of such manufacturers for supply of the Polyester Cotton yarn For Bag Closing quality 4/10 (4 ply x 10 count) 915 mtrs length, 220 ± 5 grm. weight per cone as per our annual requirement (4000 Cones approx per year) for 1 year in parts according to our demand, strictly in accordance with the detailed specifications given in the Schedule-II

1.0 **Tender submission:**

- 1.1 The tenderers should clearly state in their offers the address for communication together with their mobile phone nos., E-mail address, telephone and Fax No. Any change in the address should immediately be notified to the I/c General Manager, Cattle Feed Factory, Pachama, Distt. Sehore so that the correspondence thereafter may be made at their changed address.
- 1.2 The Chief Executive Officer, Bhopal Sahakari Dugdh Sangh Mydt., Bhopal will have full right to accept in full , partial or split orders for supply of Polyster Thread Cone For Bag Closing quality 4/10 (4 ply x 10 count) 915 mtrs length, 220 ± 5 grm. weight per cone.

2.0 **EARNEST MONEY DEPOSIT**

- 2.1 The tenderers shall have to deposit Rs. 10,000/-(Rupees Ten Thousand) as Earnest money through online. MSME of the M.P. State are Exempted from EMD
- 2.2 The earnest money deposit of the successful tenderers shall be released on completion of successful supply of entire quantity allotted/ordered within the stipulated period..
- 2.3 No interest will be paid on the earnest money for the period during which it (the earnest money) lies in deposit with the Cattle Feed Factory, Pachama, Distt. Sehore.

3.0 PRICES:

3.1 The prices should be quoted F.O.R. Destination inclusive of packing forwarding, GST, insurance & transportation charges etc.

4.0 **MODE OF DESPATCH:**

- 4.1 On receiving orders from Cattle Feed Factory, Pachama the supply of material at Cattle Feed Plant, shall be the responsibility of the supplier Quality inspection and rejection if any, shall be made at the Cattle Feed Plant Sites, the rejected quantity, if any, shall be lifted by the supplier at his own cost. The rejected material shall have to be lifted by the supplier within a week time from the date of intimation from Cattle Feed Plant. The Cattle Feed Plant shall not be responsible for any deterioration due to delayed lifting of the rejected material by the supplier.
- 4.2 Polyester Cotton yarn For Bag Closing quality 4/10 (4 ply x 10 count) 915 mtrs length, 220 ± 5 grm. weight per cone to be suitably packed to prevent damages during transit.

5.0 **INSURANCE**:

5.1 Insurance shall be arranged by the Supplier at his cost. The Cattle Feed Factory, Pachama will not be responsible for any transit damages and losses.

6.0 **PAYMENT**:

6.1 Our normal terms of payment is full payment on acceptance of material after inspection within a period of thirty days after receipt. The quality of thread will be examined at the Govt. Approved lab on the basis of which the payment can be made. All payment shall be made through RTGS only.

7.0 **STATUS OF TENDER:**

7.1 The acceptance of the tender and award of the purchase order will be the sole right of the CEO, Bhopal Sahakari Dugdh Sangh Mydt., Bhopal who does not bind himself to accept a tender in whole or in part. He reserves the right to reject any or all the tenders or their without assigning any reasons.

8.0 <u>LIQUIDATED DAMAGES & PENALTIES:</u>

8.1 The time period and the date of delivery of the material stipulated in the purchase order shall be deemed to be the essence of the contract. Ones firm delivery date(s) are fixed for supply of material they shall be strictly adhered to. In case they are not followed, the - Dugdh Sangh reserves the right to cancel the order and make alternative purchases from other sources at the risk and cost & expenses of the defaulting supplier. In case the supplies are not affected as per schedules the liquidated damages may be charged on the goods not so delivered as under:-

Duration of delay

- a) Up to 15 Days
- b) Between 16 to 30 Days
- c) Beyond 30 Days
- 5% of the value of good

Liquidated Damages

1% of the value of goods. 2% of the value of goods.

9.0 **REQUIRMENT & REJECTION:**

- 9.1 Requirement of Polyester Cotton yarn For Bag Closing quality 4/10 (4 ply x 10 count) 915 mtrs length, 220 ± 5 grm. weight per cone.
- 9.2 Quality: The quality of thread will be examined at the Govt. approved lab. On the basis of report, material can be accepted and accordingly payment shall be released.
- 9.3 Polyester Cotton yarn For Bag Closing quality 4/10 (4 ply x 10 count) 915 mtrs length, 220 ± 5 grm. Weight per cone shall be rejected in case of following:
 - A. length of the thread is not uniform.
 - B. Poor Quality by weight.

10.0 TERMINATION OF CONTRACT:-

Any breach of the terms and conditions of contract shall render the contract liable to termination and/or blacklisting of the firm, and forfeit of earnest money deposited

11.0 FINAL AUTHORITY:-

- 11.1 It should be clearly understood that in the event of tenderer failing to accept and execute the supply order, decision of the CEO, Bhopal Sahakari Dugdh Sangh Mydt., Bhopal for imposing penalty etc. Shall be final and binding on the tenderer.
- 11.2 In matters of interpretation of the above clauses, the decision of the CEO, Bhopal Sahakari Dugdh Sangh Mydt., Bhopal shall be final and binding on all concerned.
- 11.3 For all disputes the jurisdiction shall be Bhopal. No court outside Bhopal will have any jurisdiction.

12.0 **ARBITRATION:**

12.1 In case of any dispute, if arises between the parties relating to any terms and conditions of the Tender/Agreement and/or regarding the Agreement/Tender before or after the filing of the Tender and/or execution of the Agreement, any party may refer the dispute to a Sole Arbitrator who will be the MD MPCDF Bhopal whose decision and award shall be final and binding to both the parties. The arbitration proceedings shall be under and accordance with the provision of Arbitration and Conciliations Act 1996.

13.0 **AGREEMENT:**

13.1 Approved tenderers shall have to execute an agreement on Rs.1000/- non-judicial stamp Paper as per terms and conditions of this tender with the Cattle Feed Plant Pachama which shall be valid till Two year from the date of award of contract. The contract period can be increased for two more year mutually.
